

ORDER

WHEREAS in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (No. 1993) and in supersession of the National Council for Teacher Education (Recognition) Rules and Procedural Regulations, 2007, the National Council for Teacher Education has notified the Regulations, 2014 (No. 1) 2014.

AND WHEREAS the institution viz. **Saltora Education College, PO - Saltora, Dist. Bardhaman, West Bengal - 722 118** was granted recognition for conduct of B.Ed. course of one year duration with an annual intake of 100 from the academic session 2008-2009 vide REC order No. REC/748(43)/17/2008/100A dt. 23.08.2008.

AND WHEREAS the institution viz. **Saltora Education College, PO - Saltora, Dist. Bardhaman, West Bengal - 722 118** has by affidavit dated 14.01.2015 consented to come under the Regulations 2014 and sought for the benefits in B.Ed. course which require additional facilities.

AND WHEREAS it has been decided to permit the institution to have the basic, viz. a) Students each added to falling following conditions, namely:

(i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff and (d) agree to shift name to per Regulations 2014 and inform Regional Committee with required documents by October 31, 2015.

(ii) The application/institution for additional unit will be required to submit the required documents such as land document, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the visiting team at the time of inspection.

(iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 30.10.2015. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2014-2015.

AND WHEREAS in the light of the above and in terms of Section 14(3) of the NCTE Act and in accordance with the Regulations, 2014 of the Eastern Regional Committee, NCTE hereby grants recognition, to **Saltora Education College, PO - Saltora, Dist. Bardhaman, West Bengal - 722 118** for conducting B.Ed. Programme of two years duration with an annual intake of 100 for the academic year 2014-2015.

AND WHEREAS the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

AND WHEREAS the institution shall submit to the Regional Committee a self appraisal report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

AND WHEREAS the institution shall maintain & update its website at the provision of NCTE Regulations and always display following as mandatory disclosure:

(a) Detailed program along with annual intake in the institution.
(b) Name of faculty and staff as laid as mentioned in school certificate along with their qualifications, scale of pay and photograph.
(c) Name of faculty members who left or joined during the last quarter.
(d) Name of students admitted during the current session along with qualifications, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
(e) Fee charged from students.
(f) Academic infrastructure facilities.
(g) Facilities added during the last quarter.
(h) Number of books in the library, journals subscribed to and circulation, if any in the last quarter.
(i) The school with enclosure submitted along with application.
(j) The institution shall be free to post additional relevant information, if it so desires.


AND WHEREAS the institution shall comply with the above conditions of the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under. The institution will require final action to promote action including withdrawal of recognition by the Regional Committee under the provisions of Section 17 (1) of the NCTE Act.
